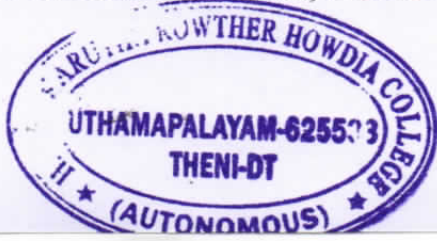

## Action Taken Report 2013-2014

In accordance with the resolutions passed during the IQAC meetings, the following actions were taken during the academic year 2013-2014.

1. The Management appointed Dr. M. Syed Meera Lebbai, Associate Professor of Commerce as the Controller of Examinations from the year 2013.
2. The office of the Controller of Examinations and an ICT enabled Seminar Hall was opened.
3. Following the grant of Autonomous Status, the Board of Studies meeting of all the departments was conducted to frame a new syllabus for students of UG and PG from the year 2013-14.
4. The renovation work of Computer Science Laboratory was initiated.
5. Research activities started increasing with the publication of Research Articles, Paper Presentations, Book Publications, Editing Books etc. Staff members started showing keen interest in obtaining Ph.D.
6. To cater to the needs of the women students, the newly constructed ladies hostel was started.
7. For the conveyance of women staff and students, two more buses were added for their transportation.
8. Construction work of Indoor and Outdoor stadiums was completed and added to the existing sports facilities.
9. To generate renewable energy, a Solar Panel with a power capacity of 15kw was installed. To confront the power shutdown in the college, a Generator with 35kw capacity was installed.
10. A programme to commemorate the 150<sup>th</sup> Anniversary of Swami Vivekananda was organized in the college.
