ANTI-RAGGING POLICY

The college has Anti-ragging Policy to make the college campus a ragging free (0% Ragging) campus.

The following are the core aspects of the Anti-Ragging Policy.

1. The College has been mentioning the aspects of ragging in the Prospectus so that Parents and Students can learn about Anti-Ragging rules at the time of admission.
2. The Educational Institution's Anti-Ragging Committee and Anti-Ragging Squad Policies, phone numbers, and instruction manual are all included in the College brochure.
3. Every year the affidavits from every student and their Parents stating that they will not engage in ragging are received. The phone numbers, names and full addresses of the students and parents are also collected.
4. The College has been creating awareness about ragging by displaying stickers, posters and paintings in the campus for explaining and adhering the legal rules of ragging.
5. The Hostel Wardens constantly monitor ragging in the dormitory areas with the support of the Anti-Ragging Squad. Due to online classes, the hostel is currently closed and will be closely monitored after the commencement of regular classes.
6. Each new student is provided with a printed pamphlet mentioning the information related to Anti-Ragging Committee.
7. The college assures that students who complain about ragging at our Educational Institution are kept confidential by the Committee members and the Police. So far, the College has not received any such complaints.
8. Mentors are assigned for the first year students. A record of the dates of the sudden visit of the Mentors is also maintained. Students who have stress are advised to consult the college Psychiatrist who monitors and counsels them.
9. The College has accommodation facilities for only women students. First year women students are provided accommodation in the ground floor.
10. The College sends letters to the parents/guardians of first year students mentioning ragging rules.



11. The College has established an Anti-Ragging Committee to incorporate UGC regulations. With the Principal as Head, the Anti-Ragging Committee, includes representatives from the Civil and Police Administrations, local media, NGOs involved in Youth Activities, Faculty Members, Parents, and Newly Enrolled Students. This Anti-Ragging Committee constituted based on UGC regulations has been active since the Academic Year 2021-2022.
12. The Anti-Ragging Committee of the college is responsible for enforcing and ensuring compliance with UGC standards.
13. The Head of the Educational Institution advocates to the UGC guidelines for maintaining an Anti-Ragging Committee in the Institution. This Committee follows strict regulations and creates awareness about ragging, monitors and patrols actions, and is vigilant and active.
14. Raids on the College women hostel are undertaken by women faculty members of the Anti-Ragging Squad.
15. The College performs sensible randomised surveys of First Year student. This academic year (2021-2022) only First Year Post Graduate students have access to regular classes and so this survey is collected from them.
16. The College constantly sends weekly Anti-Ragging reports to the appropriate Institution. The monthly reports are also submitted to the District Collector.
17. The College follows the norms set forth by the UGC. So far, the Institution has not received any such ragging complaints yet continues to function effectively.
